#### 1 Name

This instrument is the *Primary Industries Levies and Charges Disbursement (List of Declared Recipient Bodies) Instrument 2024.* 

#### 2 Commencement

This instrument is made under subsection 39(9) of the *Primary Industries Levies* and Charges Disbursement Act 2024.

#### 4 Definitions

Act means the Primary Industries Levies and Charges Disbursement Act 2024.

**Declared Bodies Rules** means the *Primary Industries Levies and Charges Disbursement (Declared Bodies) Rules 2024.* 

### 5 List of declared recipient bodies
