A BILL

To place certain restrictions on Immigration and to provide for the removal from the Commonwealth of prohibited Immigrants.

BE it enacted by the King's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, as follows:—

(1) The Minister, or any Collector of Customs specially empowered by him, may by writing under his hand authorize any officer to detain any vessel from which any prohibited immigrant has, in the opinion of the officer, entered the Commonwealth contrary to this Act ; and the vessel may then be detained either at the place where she is found, or at any place to which the Minister or Collector may order her to be brought. 15

Powers of detaining officer.

(2) For the purposes of the detention and other lawful dealing with the vessel the officer so authorized shall be entitled to obtain such writ of assistance or other aid as is provided under any law relating to the Customs with respect to the seizure of vessels or goods. 20

Detention to cease if bond given.

(3) The detention shall be for safe custody only, and shall cease if a bond with two sufficient sureties to the satisfaction of the Minister or the collector be given by the master owners or charterers of the vessel for the payment of any penalty which may be adjudged under this Act to be paid for the offence or default. 25

Sale of vessel on default.

(4) If default is made in payment of any such penalty, the officer may seize the vessel ; and the like proceedings shall thereupon be taken for forfeiting and condemning the vessel as in the case of a vessel seized for breach of any law relating to the Customs, and the vessel shall be sold. 30

Application of proceeds.

(5) The proceeds of the sale shall be applied first in payment of the penalty and of all costs incurred in and about the sale and the proceedings leading thereto, and the balance shall be paid to the owners of or other persons lawfully entitled to the vessel before condemnation and sale. 35

(3) All such regulations shall be laid before both Houses of the Parliament within thirty days after the making thereof if the Parliament be then sitting, and if not then within thirty days after the next meeting of the Parliament.

16. Where no higher penalty is expressly imposed, a person guilty of any offence against this Act, or against any regulation made thereunder, shall be liable on summary conviction to a penalty not exceeding Fifty pounds, and in default of payment to imprisonment with or without hard labour for any period not exceeding three months.

“No penalty shall be imposed under this section on any master or owner who proves to the satisfaction of the Court that he had no knowledge of any prohibited immigrant being landed contrary to this Act, and that he took all reasonable precautions to prevent it.”

Clause 10, omit “in the opinion of the officer,” in line 15.

(*Mr. Crouch.*)

Clause 17, insert before the word “This,” in line 28, the words “Until the first day of March, One thousand nine hundred and two.”

Mr. Mahon to move that the following New Clause be added to the Bill :—

New Clause (to follow Clause 8)—

8A. Any person coming within the definitions of a prohibited immigrant contained in section four and any aboriginal native of Asia Africa or Polynesia who is convicted of murder or manslaughter or rape or an aggravated assault or an attempt to commit any such offence shall be liable on the expiration of any term of imprisonment imposed on him therefor to be deported from the Commonwealth pursuant to any warrant of the Minister.

- Clause 11, line 22, before "shall" insert "or makes any contract or agreement the performance of which would be a contravention of this Act."
