## A Bill for an Act to amend legislation relating to defence, and for related purposes

The Parliament of Australia enacts:

#### 1 Short title

This Act may be cited as the *Defence Legislation (Miscellaneous Amendments) Act 2008.* 

#### 2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

22	1. The High Contracting Parties undertake to respect and to ensure respect for
23	this Protocol in all circumstances.
24	2. This Protocol reaffirms and supplements the provisions of the four Geneva
25	Conventions of 12 August 1949 ("the Geneva Conventions") and, where applicable, of their two Additional Protocols of 8 June 1977 ("the 1977
26	Additional Protocols') relating to the distinctive emblems, namely the red cross,
27	the red crescent and the red lion and sun, and shall apply in the same situations
28 29	as those referred to in these provisions.

32	Article 2 - Distinctive emblems
33	
34	1. This Protocol recognizes an additional distinctive emblem in addition to,
35	and for the same purposes as, the distinctive emblems of the Geneva
36	Conventions. The distinctive emblems shall enjoy equal status.

38	2. This additional distinctive emblem, composed of a red frame in the shape of
39	a square on edge on a white ground, shall conform to the illustration in the
40	Annex to this Protocol. This distinctive emblem is referred to in this Protocol as
41	the "third Protocol emblem".

#### International

#### Federation of Red Cross and Red Crescent Societies

The International Committee of the Red Cross and the International Federation of Red Cross and Red Crescent Societies, and their duly authorized personnel, may use, in exceptional circumstances and to facilitate their work, the distinctive emblem referred to in Article 2 of this Protocol.

#### Article 5 - Missions under United Nations auspices

The medical services and religious personnel participating in operations under the auspices of the United Nations may, with the agreement of participating States, use one of the distinctive emblems mentioned in Articles 1 and 2.

#### Article 6 - Prevention and repression of misuse

1. The provisions of the Geneva Conventions and, where applicable, the 1977 Additional Protocols, governing prevention and repression of misuse of the distinctive emblems shall apply equally to the third Protocol emblem. In particular, the High Contracting Parties shall take measures necessary for the prevention and repression, at all times, of any misuse of the distinctive emblems mentioned in Articles 1 and 2 and their designations, including the perfidious use and the use of any sign or designation constituting an imitation thereof.

2. Notwithstanding paragraph 1 above, High Contracting Parties may permit prior users of the third Protocol emblem, or of any sign constituting an imitation thereof, to continue such use, provided that the said use shall not be such as would appear, in time of armed conflict, to confer the protection of the Geneva Conventions and, where applicable, the 1977 Additional Protocols, and provided that the rights to such use were acquired before the adoption of this Protocol.

#### Article 7 - Dissemination

The High Contracting Parties undertake, in time of peace as in time of armed conflict, to disseminate this Protocol as widely as possible in their respective countries and, in particular, to include the study thereof in their programmes of military instruction and to encourage the study thereof by the civilian population, so that this instrument may become known to the armed forces and to the civilian population.

1 Article 8 - Signature 2 3 This Protocol shall be open for signature by the Parties to the Geneva 4 Conventions on the day of its adoption and will remain open for a period of 5 twelve months. 6 7 8 Article 9 - Ratification 9 This Protocol shall be ratified as soon as possible. The instruments of 10 ratification shall be deposited with the Swiss Federal Council, depositary of the 11 Geneva Conventions and the 1977 Additional Protocols. 12 13 14 Article 10 - Accession 15 This Protocol shall be open for accession by any Party to the Geneva 16 Conventions which has not signed it. The instruments of accession shall be 17 deposited with the depositary. 18 19 20 Article 11 - Entry into force 21 22 1. This Protocol shall enter into force six months after two instruments of 23 ratification or accession have been deposited. 24 2. For each Party to the Geneva Conventions thereafter ratifying or acceding to 25 this Protocol, it shall enter into force six months after the deposit by such Party 26 of its instrument of ratification or accession. 27 28 29 Article 12 - Treaty relations upon entry into force of this Protocol 30 1. When the Parties to the Geneva Conventions are also Parties to this 31 Protocol, the Conventions shall apply as supplemented by this Protocol. 32 2. When one of the Parties to the conflict is not bound by this Protocol, the 33 Parties to the Protocol shall remain bound by it in their mutual relations. They 34 shall furthermore be bound by this Protocol in relation to each of the Parties 35 which are not bound by it, if the latter accepts and applies the provisions 36 thereof. 37 38 39 Article 13 - Amendment 40 41

1	1. Any High Contracting Party may propose amendments to this Protocol. The
2	text of any proposed amendment shall be communicated to the depositary,
3	which shall decide, after consultation with all the High Contracting Parties, the
4	International Committee of the Red Cross and the International Federation of
5	Red Cross and Red Crescent Societies, whether a conference should be
6	convened to consider the proposed amendment.

8	2. The depositary shall invite to that conference all the High Contracting
9	Parties as well as the Parties to the Geneva Conventions, whether or not they are
10	signatories of this Protocol.

13	Article 14 - Denunciation
14	
15	1. In case a High Contracting Party should denounce this Protocol, the
16	denunciation shall only take effect one year after receipt of the instrument of
17	denunciation. If, however, on the expiry of that year the denouncing Party is
18	engaged in a situation of armed conflict or occupation, the denunciation shall
19	not take effect before the end of the armed conflict or occupation.
20	2. The denunciation shall be notified in writing to the depositary, which shall
21	transmit it to all the High Contracting Parties.
22	3. The denunciation shall have effect only in respect of the denouncing Party.
23	4. Any denunciation under paragraph 1 shall not affect the obligations already
24	incurred, by reason of the armed conflict or occupation, under this Protocol by such denouncing Party in respect of any act committed before this denunciation
25	becomes effective.

30	The depositary shall inform the High Contracting Parties as well as the Parties
31	to the Geneva Conventions, whether or not they are signatories of this Protocol,


