3     The Parliament of Australia enacts:

4     **1 Short title**

5                     This Act may be cited as the *Transport Safety Investigation*  
6                     *Amendment Act 2009*.

7     **2 Commencement**

8                     (1) Each provision of this Act specified in column 1 of the table  
9                     commences, or is taken to have commenced, in accordance with  
10                    column 2 of the table. Any other statement in column 2 has effect  
11                    according to its terms.

1 **Part 2—Australian Transport Safety Bureau**

2 **Division 1—Establishment, functions and powers of**  
3 **Bureau**

4 **12 Establishment of the Australian Transport Safety Bureau**  
5 **(ATSB)**

6 The Australian Transport Safety Bureau (*ATSB*) is established by  
7 this section.

8 **12A Constitution of the ATSB**

- 9 (1) The ATSB consists of:  
10 (a) a Chief Commissioner; and  
11 (b) 2 or more Commissioners.
- 12 (2) The performance of a function or the exercise of a power of the  
13 ATSB is not affected by a vacancy in the membership of the  
14 ATSB.

15 **12AA Functions of the ATSB**

- 16 (1) The ATSB's function is to improve transport safety by means that  
17 include the following:  
18 (a) receiving and assessing reports of transport safety matters,  
19 reportable matters, and other safety information that is  
20 prescribed by the regulations;  
21 (b) independently investigating transport safety matters;  
22 (c) identifying factors that:  
23 (i) contribute, or have contributed, to transport safety  
24 matters; or  
25 (ii) affect, or might affect, transport safety;  
26 (d) communicating those factors to relevant sectors of the  
27 transport industry and the public in any way, including in any  
28 one or more of the following ways:  
29 (i) by making safety action statements;  
30 (ii) by making safety recommendations;  
31 (iii) by issuing safety advisory notices;

- 1 (e) reporting publicly on those investigations;  
2 (f) conducting public educational programs about matters  
3 relating to transport safety;  
4 (g) any other means prescribed by the regulations.
- 5 (2) The ATSB also has the following functions:  
6 (a) cooperating with:  
7 (i) an agency of the Commonwealth, a State or Territory  
8 that has functions or powers relating to transport safety  
9 or functions affected by the ATSB's function of  
10 improving transport safety; and  
11 (ii) a person who has, under a law of the Commonwealth, a  
12 State or Territory, functions or powers relating to  
13 transport safety or functions affected by the ATSB's  
14 function of improving transport safety; and  
15 (iii) a national authority or other body of another country  
16 that has functions or powers relating to transport safety  
17 or functions affected by the ATSB's function of  
18 improving transport safety;  
19 (b) doing anything incidental to its function of improving  
20 transport safety.
- 21 (3) The following are not functions of the ATSB:  
22 (a) to apportion blame for transport safety matters;  
23 (b) to provide the means to determine the liability of any person  
24 in respect of a transport safety matter;  
25 (c) to assist in court proceedings between parties (except as  
26 provided by this Act, whether expressly or impliedly);  
27 (d) to allow any adverse inference to be drawn from the fact that  
28 a person was involved in a transport safety matter.
- 29 However, even though blame or liability may be inferred, or an  
30 adverse inference may be made, by a person other than the ATSB,  
31 this does not prevent the ATSB from carrying out its functions.
- 32 (4) To avoid doubt, subsection (3) does not prevent the prosecution of  
33 any offence under this Act.

1 **12AB Independence of the ATSB and Chief Commissioner**

- 2 (1) Subject to section 21, the ATSB is not subject to direction from  
3 anyone in relation to the performance of its functions or the  
4 exercise of its powers.
- 5 (2) The Chief Commissioner is not subject to direction from anyone in  
6 relation to the exercise of his or her powers. However, when  
7 exercising his or her powers, the Chief Commissioner must act  
8 consistently with the ATSB in the performance of its functions or  
9 the exercise of its powers.

10 Note: This means that the ATSB and the Chief Commissioner would not, for  
11 example, be subject to direction from anyone in relation to:

- 12 (a) how a particular investigation will be carried out; or  
13 (b) the content of a public report on a particular investigation.

14 **12AC Minimal disruption to transport services**

15 In exercising powers under this Act, the ATSB and the Chief  
16 Commissioner must have regard to the desirability of minimising  
17 any resulting disruption to transport by means of transport vehicles.

18 **12AD International obligations**

- 19 (1) The ATSB must ensure that the ATSB's powers under this Act are  
20 exercised in a manner that is consistent with Australia's obligations  
21 under international agreements (as in force from time to time) that  
22 are identified by the regulations for the purpose of this section.
- 23 (2) The Chief Commissioner must ensure that the Chief  
24 Commissioner's powers under this Act are exercised in a manner  
25 that is consistent with Australia's obligations under international  
26 agreements (as in force from time to time) that are identified by the  
27 regulations for the purpose of this section.
- 28 (3) In exercising powers under this Act, the ATSB and the Chief  
29 Commissioner must also have regard to any rules,  
30 recommendations, guidelines, codes or other instruments (as in  
31 force from time to time) that are promulgated by an international  
32 organisation and that are identified by the regulations for the  
33 purposes of this section.

1 **12AE Minister may give the ATSB notices about its strategic**  
2 **direction**

- 3 (1) The Minister may, by written instrument, notify the ATSB of the  
4 Minister's views on the appropriate strategic direction for the  
5 ATSB.
- 6 (2) Subject to section 12AB, the ATSB must have regard to a  
7 notification given under subsection (1).
- 8 (3) A notification given under subsection (1) is not a legislative  
9 instrument.

10 **Division 2—Appointment of Commissioners**

11 **13 Appointment**

- 12 (1) The Chief Commissioner is to be appointed by the Minister by  
13 written instrument, on a full-time basis.

14 Note: The Chief Commissioner is also the Chief Executive Officer: see  
15 section 15.

- 16 (2) Other Commissioners are to be appointed by the Minister by  
17 written instrument, on a part-time basis.
- 18 (3) A person is eligible to be appointed as a Commissioner only if the  
19 person has a high level of expertise in one or more areas relevant to  
20 the ATSB's functions.
- 21 (4) A person's appointment as a Commissioner is not invalid because  
22 of a defect or irregularity in connection with the person's  
23 appointment.

24 **13A Term of appointment**

- 25 (1) The Chief Commissioner holds office for the period specified in  
26 the instrument of appointment. The period must not exceed 5 years.
- 27 (2) A part-time Commissioner holds office for the period specified in  
28 the instrument of appointment. The period must not exceed 3 years.

29 Note: A Commissioner is eligible for reappointment: see subsection 33(4A)  
30 of the *Acts Interpretation Act 1901*.

1 **13AA Remuneration and allowances**

- 2 (1) A Commissioner is to be paid such remuneration as is determined  
3 by the Remuneration Tribunal. If no determination of that  
4 remuneration is in operation, the Commissioner is to be paid such  
5 remuneration as is prescribed.
- 6 (2) A Commissioner is to be paid the allowances that are prescribed.
- 7 (3) This section has effect subject to the *Remuneration Tribunal Act*  
8 *1973*.

9 **13AB Leave of absence**

- 10 (1) The Chief Commissioner has the recreation leave entitlements that  
11 are determined by the Remuneration Tribunal.
- 12 (2) The Minister may grant to the Chief Commissioner leave of  
13 absence, other than recreation leave, on the terms and conditions as  
14 to remuneration that the Minister determines.
- 15 (3) The Chief Commissioner may grant leave of absence to a part-time  
16 Commissioner on the terms and conditions that the Chief  
17 Commissioner determines.

18 **13AC Outside employment**

- 19 (1) The Chief Commissioner must not engage in paid employment  
20 outside the duties of the Chief Commissioner's office without the  
21 Minister's written consent.
- 22 (2) A part-time Commissioner must not engage in any paid  
23 employment that conflicts or may conflict with the proper  
24 performance of his or her duties without the Minister's written  
25 consent.

26 **13AD Resignation**

- 27 (1) A Commissioner may resign by giving to the Minister a signed  
28 notice of resignation.
- 29 (2) If the Chief Commissioner resigns, he or she also resigns his or her  
30 position as the Chief Executive Officer.

1 Note: Subsection (2) does not prevent a person who is both the Chief  
2 Commissioner and the Chief Executive Officer from being  
3 re-appointed only as a part-time Commissioner.

4 (3) The resignation takes effect on the day on which it is received by  
5 the Minister or, if a later day is specified in the resignation, on that  
6 later day.

7 **13AE Disclosure of interests to the Minister**

8 A Commissioner must give written notice to the Minister of all  
9 interests, pecuniary or otherwise, that the Commissioner has or  
10 acquires and that conflict or could conflict with the proper  
11 performance of the ATSB's functions.

12 **13AF Other terms and conditions**

13 A Commissioner holds office on such terms and conditions (if any)  
14 in relation to matters not provided for by this Act as are  
15 determined, in writing, by the Minister.

16 **13AG Termination of appointment**

17 *All Commissioners*

18 (1) The Minister may terminate the appointment of a Commissioner:  
19 (a) for misbehaviour or physical or mental incapacity; or  
20 (b) if the Commissioner:  
21 (i) becomes bankrupt; or  
22 (ii) applies to take the benefit of any law for the relief of  
23 bankrupt or insolvent debtors; or  
24 (iii) compounds with his or her creditors; or  
25 (iv) makes an assignment of his or her remuneration for the  
26 benefit of his or her creditors; or  
27 (c) if the Commissioner fails, without reasonable excuse, to  
28 comply with section 13AE.

29 *Additional grounds: Chief Commissioner*

30 (2) The Minister may terminate the appointment of the Chief  
31 Commissioner if:

- 1 (a) the Commissioner is absent, except on leave of absence, for  
2 14 consecutive days or for 28 days in any 12 months; or  
3 (b) the Commissioner engages, except with the Minister's  
4 written consent, in paid employment outside the duties of his  
5 or her office.

6 *Additional grounds: part-time Commissioners*

- 7 (3) The Minister may terminate the appointment of a part-time  
8 Commissioner if:  
9 (a) the Commissioner engages, except with the Minister's  
10 written consent, in paid employment that conflicts or may  
11 conflict with the proper performance of the Commissioner's  
12 duties; or  
13 (b) the Commissioner is absent, except on leave of absence  
14 granted under section 13AB, from 3 consecutive meetings of  
15 the ATSB.

16 **13AH Acting Chief Commissioner**

- 17 (1) The Minister may appoint a person to act as the Chief  
18 Commissioner:  
19 (a) during a vacancy in the office of the Chief Commissioner,  
20 (whether or not an appointment has previously been made to  
21 the office); or  
22 (b) during any period, or during all periods, when the Chief  
23 Commissioner:  
24 (i) is absent from duty or from Australia; or  
25 (ii) is, for any reason, unable to perform the duties of the  
26 office.
- 27 (2) To avoid doubt, a part-time Commissioner or staff member (within  
28 the meaning of paragraph (b) of the definition of that expression)  
29 may be appointed to act as the Chief Commissioner.
- 30 (3) Anything done by or in relation to a person purporting to act under  
31 an appointment is not invalid merely because:  
32 (a) the occasion for the appointment had not arisen; or  
33 (b) there is a defect or irregularity in connection with the  
34 appointment; or  
35 (c) the appointment had ceased to have effect; or



1 (d) the occasion to act had not arisen or had ceased.

2 Note: See sections 20 and 33A of the *Acts Interpretation Act 1901*.

3 **Division 3—ATSB procedures**

4 **Subdivision A—Meetings**

5 **14 Times and places of meetings**

6 (1) The Chief Commissioner must hold such meetings as are necessary  
7 for the efficient performance of the ATSB's functions.

8 (2) Meetings are to be held at such times and places as the Chief  
9 Commissioner decides.

10 **14A Conduct of meetings**

11 *Presiding at meetings*

12 (1) The Chief Commissioner presides at all meetings at which he or  
13 she is present.

14 (2) If the Chief Commissioner is not present at a meeting, a person  
15 appointed to act as the Chief Commissioner must be present and  
16 preside.

17 *Quorum*

18 (3) At a meeting of the ATSB, a quorum is constituted by 2  
19 Commissioners.

20 *Rules of procedure*

21 (4) The ATSB may, subject to this Subdivision, regulate proceedings  
22 at its meetings as it considers appropriate.

23 Note: Section 33B of the *Acts Interpretation Act 1901* provides for  
24 participation in meetings by telephone etc.

25 *Voting*

26 (5) The person presiding at a meeting of the ATSB has a deliberative  
27 vote and, if the votes are equal, also has a casting vote.

1 *Minutes*

2 (6) The ATSB must ensure that minutes of its meetings are kept.

3 **14AA Disclosure of interests**

4 (1) If a Commissioner has an interest, pecuniary or otherwise, in a  
5 matter being considered, or about to be considered, at the meeting,  
6 the Commissioner must disclose the nature of that interest to the  
7 other Commissioners.

8 (2) The disclosure must be made as soon as possible after the relevant  
9 facts have come to the Commissioner's knowledge.

10 (3) The disclosure must be recorded in the minutes of the meeting.

11 (4) Unless the ATSB otherwise determines, the Commissioner:  
12 (a) must not be present during the ATSB's deliberation on the  
13 matter; and  
14 (b) must not take part in the ATSB's decision on the matter.

15 (5) A determination under subsection (4) must be recorded in the  
16 minutes of the meeting.

17 **Subdivision B—Decisions without meetings**

18 **14AB Decisions without meetings**

19 (1) A decision is taken to have been made at a meeting of the ATSB if:  
20 (a) without meeting, a majority of Commissioners indicate  
21 agreement with the proposed decision in accordance with the  
22 method determined by the ATSB under subsection (2); and  
23 (b) all Commissioners were informed of the proposed decision,  
24 or reasonable efforts were made to inform all Commissioners  
25 of the proposed decision.

26 (2) Subsection (1) applies only if the ATSB:  
27 (a) has determined that it applies; and  
28 (b) has determined the method by which Commissioners are to  
29 indicate agreement with proposed decisions.

1 **14AC Record of decisions**

2 The ATSB must keep a record of decisions made in accordance  
3 with section 14AB.

4 **Division 4—Chief Executive Officer**

5 **15 Chief Executive Officer**

- 6 (1) There is to be a Chief Executive Officer of the ATSB.  
7 (2) The Chief Commissioner is the Chief Executive Officer.

8 **15A Functions of the Chief Executive Officer**

- 9 (1) The Chief Executive Officer is to manage the ATSB in accordance  
10 with the policies determined by the ATSB.  
11 (2) All acts and things done in the name of, or on behalf of, the ATSB  
12 by the Chief Executive Officer are taken to have been done by the  
13 ATSB.

14 **Division 5—Staff and consultants**

15 **16 Staff**

- 16 (1) The staff of the ATSB are to be persons engaged under the *Public*  
17 *Service Act 1999*.  
18 (2) For the purposes of the *Public Service Act 1999*:  
19 (a) the Chief Executive Officer and the staff of the ATSB  
20 together constitute a Statutory Agency; and  
21 (b) the Chief Executive Officer is the Head of that Statutory  
22 Agency.

23 **16A Staff to be made available to the ATSB**

- 24 (1) The ATSB is to be assisted by:  
25 (a) officers and employees of Agencies (within the meaning of  
26 the *Public Service Act 1999*), and of authorities of the  
27 Commonwealth, whose services are made available to the

1                                   ATSB in connection with the performance of its functions or  
2                                   the exercise of its powers; and  
3                                   (b) persons whose services are made available under  
4                                   arrangements made under subsection (2).

5                                   (2) The Chief Executive Officer may arrange with the appropriate  
6                                   authority or officer of the government of a State or Territory for the  
7                                   State or Territory to make officers or employees available to the  
8                                   ATSB to perform services in connection with the performance of  
9                                   the ATSB's functions or the exercise of its powers.

10                                  (3) An arrangement under subsection (2) may provide for the  
11                                  Commonwealth to reimburse a State or Territory with respect to  
12                                  the services of a person or persons to whom the arrangement  
13                                  relates.

14                                  (4) When performing services for the ATSB under this section, a  
15                                  person is subject to the directions of the Chief Executive Officer.

#### 16   **16B Consultants**

17                                  (1) The ATSB may engage persons having suitable qualifications and  
18                                  experience as consultants to the ATSB.

19                                  (2) The terms and conditions of engagement are to be determined by  
20                                  the Chief Executive Officer.

#### 21   **25 Subsections 19(4) and (5)**

28 performed or exercised, as it would have been had paragraph 425(1)(ea)  
29 and subsection 425(1AAA) of the *Navigation Act 1912* not been  
30 repealed by items 8 and 9 of the *Transport Safety Investigation*  
31 *(Consequential Amendments) Act 2003*.  
32 (2) For the purpose of paragraph 106(c) of this Part, paragraph 425(1)(ea)  
33 and subsection 425(1AAA) of the *Navigation Act 1912* continue in  
34 force, despite their repeal by items 8 and 9 of the *Transport Safety*  
35 *Investigation (Consequential Amendments) Act 2003*.
