6 The Parliament of Australia enacts:

7 **1 Short title**

8 This Act may be cited as the *Screen Australia (Transfer of Assets)*
9 *Act 2010*.

10 **2 Commencement**

11 (1) Each provision of this Act specified in column 1 of the table
12 commences, or is taken to have commenced, in accordance with

1 column 2 of the table. Any other statement in column 2 has effect
2 according to its terms.

5 **1 Definitions**

6 In this Schedule:

7 **asset** means:

- 8 (a) any legal or equitable estate or interest in real or personal
9 property, whether actual, contingent or prospective; and
10 (b) any right, power, privilege or immunity, whether actual,
11 contingent or prospective.

12 **FAL** has the same meaning as in Schedule 2 to the *Screen Australia and*
13 *the National Film and Sound Archive of Australia (Consequential and*
14 *Transitional Provisions) Act 2008.*

15 **film library** means the library of films and associated materials that
16 were previously owned by FAL and became assets and liabilities of
17 Screen Australia as a result of subitem 3(2) of Schedule 2 to the *Screen*
18 *Australia and the National Film and Sound Archive of Australia*
19 *(Consequential and Transitional Provisions) Act 2008.*

20 **film library asset** means an asset connected with the film library,
21 including:

- 22 (a) assets relating to the sale and licensing of materials within
23 the library; and
24 (b) assets relating to the use of materials within the library for
25 digital learning purposes.

26 **film library liability** means a liability connected with the film library,
27 including:

- 28 (a) liabilities relating to the sale and licensing of materials within
29 the library; and
30 (b) liabilities relating to the use of materials within the library for
31 digital learning purposes.

32 **liability** means any liability, duty or obligation, whether actual,
33 contingent or prospective.

Schedule 2 Screen Australia

Part 1 Certain assets and liabilities of Screen Australia transferred to NFSAA

1 *NFSAA* means the National Film and Sound Archive of Australia
2 mentioned in subsection 5(1) of the *National Film and Sound Archive of*
3 *Australia Act 2008*.

4 *Screen Australia* means Screen Australia established by subsection 5(1)
5 of the *Screen Australia Act 2008*.

6 *transition time* means the start of 1 July 2011.

7 **2 Film library assets and film library liabilities of Screen**
8 **Australia become assets and liabilities of NFSAA**

- 9 (1) This item applies to assets and liabilities of Screen Australia
10 immediately before the transition time.
- 11 (2) Subject to this item, at the transition time, all film library assets and
12 film library liabilities cease to be assets and liabilities of Screen
13 Australia and become assets and liabilities of NFSAA without any
14 conveyance, transfer or assignment. NFSAA becomes the successor in
15 law in relation to the film library assets and film library liabilities.
- 16 (3) Before the transition time, the Minister may determine, in writing, that
17 specified assets or liabilities of Screen Australia (other than film library
18 assets or film library liabilities) that are related to or connected with the
19 film library, are to become assets or liabilities of NFSAA.
- 20 (4) If the Minister makes a determination under subitem (3) that specified
21 assets or liabilities of Screen Australia (other than film library assets or
22 film library liabilities) are to become the assets or liabilities of NFSAA,
23 then, at the transition time, the specified assets or liabilities cease to be
24 assets or liabilities of Screen Australia and become assets or liabilities
25 of NFSAA without any conveyance, transfer or assignment. NFSAA
26 becomes the successor in law in relation to those assets or liabilities.
- 27 (5) Before the transition time, the Minister may determine, in writing, that
28 despite subitem (2), specified film library assets or film library
29 liabilities of Screen Australia:
30 (a) continue to be assets or liabilities of Screen Australia; and
31 (b) do not become assets or liabilities of NFSAA.
- 32 (6) A determination under subitem (5) has effect accordingly.
- 33 (7) A determination made under subitem (3) or (5) is not a legislative
34 instrument.
-

- 1 (8) If a film library asset or other asset that has become an asset of NFSAA
2 under this item was, immediately before the transition time, held by
3 Screen Australia on trust, that asset is taken, at and after the transition
4 time, to be held by NFSAA on trust and subject to the terms of the trust
5 on which the asset was so held by Screen Australia.

6 **3 Certificates for vesting of assets**

- 7 (1) This item applies if:
8 (a) a film library asset or other asset becomes an asset of
9 NFSAA under item 2; and
10 (b) there is lodged with an assets official a certificate that:
11 (i) is signed by the Minister; and
12 (ii) identifies the asset; and
13 (iii) states that the asset has become vested in NFSAA under
14 this Act.
- 15 (2) The assets official may:
16 (a) deal with, and give effect to, the certificate as if it were a
17 proper and appropriate instrument for transactions in relation
18 to assets of that kind; and
19 (b) make such entries in the register in relation to assets of that
20 kind as are necessary, having regard to the effect of this Part.
- 21 (3) A certificate made under subitem (1) is not a legislative instrument.
- 22 (4) In this item:
23 *assets official* means the person or authority who, under a law of the
24 Commonwealth, a State or a Territory, or under a trust instrument or
25 otherwise, has responsibility for keeping a register in relation to assets
26 of the kind concerned.

27 **4 Certificates taken to be authentic**

- 28 A document that appears to be a certificate made under subitem 3(1):
29 (a) is taken to be such a certificate; and
30 (b) is taken to have been properly given;
31 unless the contrary is established.

32 **5 Exemption from stamp duty and other State or Territory** 33 **taxes**

Schedule 2 Screen Australia

Part 1 Certain assets and liabilities of Screen Australia transferred to NFSAA

- 1 (1) No stamp duty or other tax is payable under a law of a State or a
2 Territory in respect of an exempt matter, or anything connected with an
3 exempt matter.
- 4 (2) For the purposes of this item, an *exempt matter* is:
5 (a) the vesting of a film library asset or film library liability
6 under subitem 2(2); or
7 (b) the vesting of an asset or liability under subitem 2(4); or
8 (c) the operation of this Schedule in any other respect.
- 9 (3) The Minister may certify in writing:
10 (a) that a specified matter is an exempt matter; or
11 (b) that a specified thing is connected with a specified exempt
12 matter.
- 13 (4) In all courts, and for all purposes (other than for the purposes of
14 criminal proceedings), a certificate under subitem (3) is prima facie
15 evidence of the matters stated in the certificate.
- 16 (5) A certificate made under subitem (3) is not a legislative instrument.

Part 2—Staff of Screen Australia

6 Non-APS employees of Screen Australia transferred to NFSAA as APS employees

(1) This item applies to a person who:

6

(a) is an officer appointed, or employee engaged, by Screen Australia under subsection 31(2) of the *Screen Australia Act 2008* immediately before the transition time; and

(b) is covered by a determination that:

(i) is made under section 72 of the *Public Service Act 1999*; and

11

(ii) causes the person, at the transition time, to become a member of the staff of NFSAA engaged under the *Public Service Act 1999*.

Annual leave and personal/carer's leave

16

(2) The person is taken to have accrued an entitlement to annual leave and personal/carer's leave in connection with becoming a member of the staff of NFSAA engaged under the *Public Service Act 1999* that is equivalent to the entitlement that the person had as an officer or employee of Screen Australia immediately before the transition time.

Unpaid parental leave

22

(3) The service of the person as a member of the staff of NFSAA engaged under the *Public Service Act 1999* is taken, for the purpose of Division 5 of Part 2-2 of the *Fair Work Act 2009*, to have been continuous with his or her service as an officer or employee of Screen Australia.

Continuous service

(4) The service of the person as a member of the staff of NFSAA engaged under the *Public Service Act 1999* is taken, for all purposes, to have been continuous with his or her service as an officer or employee of Screen Australia.

5 **8 Things done by, or in relation to, Screen Australia**

- 6 (1) This item applies to a thing done by, or in relation to, Screen Australia
7 before the transition time in respect of a film library asset or a film
8 library liability (or any other asset or liability) of Screen Australia that,
9 as a result of the operation of item 2, becomes an asset or liability of
10 NFSAA.
- 11 (2) The Minister may determine, in writing, that the thing is taken, at and
12 after the transition time, to have been done by, or in relation to,
13 NFSAA.
- 14 (3) A determination made under subitem (2) has effect accordingly.
- 15 (4) The Minister may make a determination under subitem (2) before or
16 after the transition time.
- 17 (5) A determination made under subitem (2) is not a legislative instrument.
- 18 (6) This item does not limit the operation of item 2.

19 **9 References in instruments to Screen Australia**

- 20 (1) This item applies to an instrument that:
21 (a) is in force immediately before the transition time; and
22 (b) contains a reference to Screen Australia.
- 23 (2) If the instrument relates to:
24 (a) a film library asset or a film library liability (or any other
25 asset or liability) of Screen Australia that, as a result of the
26 operation of item 2, becomes an asset or liability of NFSAA;
27 or
28 (b) a thing done by, or in relation to, Screen Australia, that, as a
29 result of the operation of item 8, is taken to have been done
30 by, or in relation to, NFSAA;

Schedule 2 Screen Australia

Part 3 Things done by, references in instruments to, legal proceedings of and records or documents of Screen Australia

- 1 then the reference to Screen Australia has effect, at and after the
2 transition time, as if it were a reference to NFSAA.
- 3 (3) If subitem (2) does not apply to the instrument, then the Minister may
4 determine, in writing, that the reference to Screen Australia has effect,
5 at and after the transition time, as if it were a reference to NFSAA.
- 6 (4) A determination made under subitem (3) has effect accordingly.
- 7 (5) The Minister may make a determination under subitem (3) before or
8 after the transition time.
- 9 (6) A determination made under subitem (3) is not a legislative instrument.
- 10 (7) In this item:
11 *instrument*:
12 (a) includes:
13 (i) a contract, deed, undertaking or agreement; and
14 (ii) a notice, authority, order or instruction; and
15 (iii) an instrument made under an Act or regulations; but
16 (b) does not include:
17 (i) an Act; or
18 (ii) instruments made under this Act.

10 Legal proceedings of Screen Australia

- 19
- 20 (1) This item applies to any proceedings:
21 (a) that were pending in any court or tribunal immediately before
22 the transition time; and
23 (b) to which Screen Australia was a party.
- 24 (2) If the proceedings related, in whole or part, to a film library asset or a
25 film library liability (or any other asset or liability) that, as a result of
26 the operation of item 2, becomes an asset or liability of NFSAA, then
27 NFSAA is taken, at and after the transition time, to be substituted for
28 Screen Australia as a party to the proceedings in respect of that film
29 library asset or film library liability (or other asset or liability).
- 30 (3) If subitem (2) does not apply to the proceedings (but the proceedings
31 relate to the operation of this Schedule), then the Minister may
32 determine, in writing, that NFSAA is taken, at and after the transition

1 time, to be substituted for Screen Australia as a party to the
2 proceedings.

3 (4) A determination made under subitem (3) has effect accordingly.

4 (5) The Minister may make a determination under subitem (3) before or
5 after the transition time.

6 (6) A determination made under subitem (3) is not a legislative instrument.

7 **11 Transfer of custody of records or documents of Screen** 8 **Australia**

9 (1) This item applies to a record or document that, immediately before the
10 transition time, is in the custody of Screen Australia.

11 (2) If the record or document relates to:

12 (a) a film library asset or a film library liability (or any other
13 asset or liability) of Screen Australia that, as a result of the
14 operation of item 2, becomes an asset or liability of NFSAA;
15 or

16 (b) a thing done by, or in relation to, Screen Australia, that, as a
17 result of the operation of item 8, is taken to have been done
18 by, or in relation to, NFSAA;

19 then, after the transition time, the record or document is to be
20 transferred into the custody of NFSAA.

21 (3) If subitem (2) does not apply to the record or document (but the record
22 or document relates to the operation of this Schedule), then the Minister
23 may determine, in writing, that the record or document is to be
24 transferred after the transition time into the custody of NFSAA.

25 (4) A determination made under subitem (3) has effect accordingly.

26 (5) The Minister may make a determination under subitem (3) before or
27 after the transition time.

28 (6) A determination made under subitem (3) is not a legislative instrument.

29 (7) Section 20 of the *Commonwealth Authorities and Companies Act 1997*
30 applies in relation to accounting records transferred to a body under this
31 item as if the records were records of that body.

32 **12 Variation of the operation of this Part**

Part 3 Things done by, references in instruments to, legal proceedings of and records or documents of Screen Australia

- 1 (1) The Minister may determine, in writing, that a provision of item 9, 10 or
2 11 does not apply in relation to instruments, proceedings, records or
3 documents specified in the determination.
- 4 (2) A determination made under subitem (1) has effect accordingly, and
5 takes effect:
- 6 (a) at the time specified in the determination (which may be a
7 time before the determination is made but not a time earlier
8 than the transition time); or
- 9 (b) if a time is not specified—at the beginning of the day on
10 which the determination is made.
- 11 (3) A determination made under subitem (1) is not a legislative instrument.

2 **Part 4—Other matters**

3 **13 Transfer of appropriated money**

- 4 (1) For the purposes of the operation of an Appropriation Act after the
5 transition time, the Finance Minister may determine, by legislative
6 instrument, that one part of an amount referred to in that Act that relates
7 to Screen Australia is to be read as an amount that relates to NFSAA.
8 The determination must be related to the operation of this Schedule.
- 9 (2) A determination made under subitem (1) has effect accordingly.
- 10 (3) A determination made under subitem (1) cannot result in a change in the
11 total amount appropriated.
- 12 (4) A determination made under subitem (1) is a legislative instrument, but
13 neither section 42 (disallowance) nor Part 6 (sunsetting) of the
14 *Legislative Instruments Act 2003* applies to the determination.
- 15 (5) In this item:
16 *Appropriation Act* means an Act appropriating money for expenditure
17 out of the Consolidated Revenue Fund.
18 *Finance Minister* means the Minister administering the *Financial*
19 *Management and Accountability Act 1997*.

20 **14 Compensation for acquisition of property**

- 21 (1) If the operation of this Act would result in an acquisition of property
22 from a person otherwise than on just terms, the Commonwealth is liable
23 to pay a reasonable amount of compensation to the person.
- 24 (2) If the Commonwealth and the person do not agree on the amount of the
25 compensation, the person may institute proceedings in a court of
26 competent jurisdiction for the recovery from the Commonwealth of
27 such reasonable amount of compensation as the court determines.
- 28 (3) In this item:
29 *acquisition of property* has the same meaning as in paragraph 51(xxxi)
30 of the Constitution.
31 *just terms* has the same meaning as in paragraph 51(xxxi) of the
32 Constitution.

1 **15 Delegation by Minister**

- 2 (1) The Minister may delegate, in writing, all or any of his or her powers
3 and functions under this Act to:
4 (a) the Secretary of the Department; or
5 (b) an SES employee, or acting SES employee, in the
6 Department.
- 7 (2) In exercising powers or functions under a delegation, the delegate must
8 comply with any directions of the Minister.

9 **16 Regulations**

- 10 (1) The Governor-General may make regulations prescribing matters:
11 (a) required or permitted by this Act to be prescribed; or
12 (b) necessary or convenient to be prescribed for carrying out or
13 giving effect to this Act.
- 14 (2) In particular, regulations may be made prescribing matters of a
15 transitional nature (including prescribing any saving or application
16 provisions) relating to:
17 (a) the amendments or repeals made by this Act; or
18 (b) the employment, at or after the transition time, by NFSAA, of
19 a person appointed, engaged or employed, immediately
20 before the transition time, by Screen Australia; or
21 (c) leave of employees or staff of Screen Australia approved
22 before the transition time.

23 **17 References in this Schedule**

- 24 (1) To avoid doubt, prior to 1 July 2011 this Schedule applies as if
25 references in this Schedule to the National Film and Sound Archive of
26 Australia were references to the National Film and Sound Archive.
- 27 (2) To avoid doubt, prior to 1 July 2011 this Schedule applies as if
28 references in this Schedule to the *National Film and Sound Archive of*
29 *Australia Act 2008* were references to the *National Film and Sound*
30 *Archive Act 2008*.
