1 **A Bill for an Act to amend the law relating to**
2 **corporations and the financial sector, and for other**
3 **purposes**

4 The Parliament of Australia enacts:

5 **1 Short title**

6 This Act may be cited as the *Corporations and Financial Sector*
7 *Legislation Amendment Act 2013*.

8 **2 Commencement**

9 (1) Each provision of this Act specified in column 1 of the table
10 commences, or is taken to have commenced, in accordance with
11 column 2 of the table. Any other statement in column 2 has effect
12 according to its terms.

1 **Schedule 1—Amendments**

2 **Part 1—Payment systems and netting**

3 *Payment Systems and Netting Act 1998*

4 **1 After paragraph 16(1)(c)**

5 Insert:

- 6 (ca) any security given, in accordance with the contract, in respect
7 of obligations of a party to the contract may be enforced in
8 accordance with the contract;
- 9 (cb) rights and obligations of a party to the contract may be
10 transferred in accordance with the contract;
- 11 (cc) without limiting paragraph (cb):
- 12 (i) property (including property over which security has
13 been given) of a party to the contract may be transferred
14 or otherwise dealt with in accordance with the contract;
15 and
- 16 (ii) property (including property over which security has
17 been given) of another person on whose behalf a party
18 to the contract is acting may, with that other person’s
19 prior written consent, be transferred or otherwise dealt
20 with in accordance with the contract;

21 **2 Paragraph 16(1)(d)**

22 Omit “paragraph (c) applies”, substitute “paragraphs (c), (ca), (cb) and
23 (cc) apply”.

24 **3 After subparagraph 16(1)(d)(i)**

25 Insert:

- 26 (ia) any disposal of rights or property that may be
27 transferred in accordance with the contract; or

28 **4 Subparagraphs 16(1)(d)(ii) and (iii)**

29 After “those rights”, insert “or that property”.

30 **5 After paragraph 16(2)(f)**

31 Insert:

- 1 (fa) any security given by the party, in accordance with the
2 contract, in respect of obligations of a party to the contract
3 may be enforced in accordance with the contract;
4 (fb) rights and obligations of the party may be transferred in

7 (i) property (including property over which security has
8 been given) of the party may be transferred or otherwise
9 dealt with in accordance with the contract; and
10 (ii) property (including property over which security has
11 been given) of another person on whose behalf the party
12 is acting may, with that other person's prior written
13 consent, be transferred or otherwise dealt with in
14 accordance with the contract;

20 property in accordance with the contract.

23 (4) A reference in this section to things done, or that may be done, in
24 accordance with a contract is taken to include things done, or that
25 may be done, in accordance with any security given in accordance
26 with the contract.

27 **8 Application of amendments**

- 28 (1) In this item:
29 *start time* means the commencement of this Part.
30 (2) The amendments made by this Part apply in relation to market netting
31 contracts entered into after the start time, or that are in existence
32 immediately before the start time.
33 (3) The amendments made by this Part do not apply in relation to an
34 external administration that commenced before the start time.

- 1 (4) The amendments made by this Part apply in relation to the enforcement
2 of a security after the start time, even if the security was given before
3 the start time.
- 4 (5) The amendments made by this Part apply in relation to a transfer of, or
5 dealing with, rights, obligations or property after the start time, even if
6 those rights, obligations or property arose or were acquired before the
7 start time.
- 8 (6) The amendments made by items 2, 3 and 4 do not apply to disposals of
9 rights or property, or the creation or operation of encumbrances or
10 interests, before the start time.
- 11 (7) This item has effect subject to item 9.

12 **9 Amended provisions do not have effect to extent they**
13 **result in an acquisition of property**

- 14 (1) In this item:
15 *acquisition of property* has the same meaning as in paragraph 51(xxxi)
16 of the Constitution.
17 *just terms* has the same meaning as in paragraph 51(xxxi) of the
18 Constitution.
- 19 (2) This item applies if, because of an amendment made by this Part, the
20 operation of a provision of the *Payment Systems and Netting Act 1998*
21 would (but for this item) result in an acquisition of property otherwise
22 than on just terms.
- 23 (3) That provision of the *Payment Systems and Netting Act 1998* does not
24 apply to the extent that its operation would otherwise so result in that
25 acquisition of property.

3 overseas regulatory authority.

4 (1A) If the CS facility licensee is prescribed by the regulations for the

6 assessment at least once a year.

3 *Australian Securities and Investments Commission Act 2001*

4 **25 At the end of subsection 136(2)**

5 Add:

6 ; (k) information required to be included in the report by
7 regulations under subsection (2A).

8 **26 After subsection 136(2)**

9 Insert:

10 (2A) The regulations may require a report under subsection (1) to
11 include prescribed information relating to the exercise, by ASIC,
12 members of ASIC, or staff members, of prescribed information
13 gathering powers. For this purpose, *information gathering powers*
14 includes (but is not limited to) powers to require:

- 15 (a) the provision of information (however described, including
16 by answering questions or giving evidence); or
17 (b) the production of documents; or
18 (c) the provision of assistance.

19 Note: The information gathering powers that are prescribed may be powers
20 conferred by this Act, or by other laws.

1 **Part 5—Disclosure of information by the Reserve**
2 **Bank**

3 ***Reserve Bank Act 1959***

4 **27 Subsection 79A(1) (paragraph (e) of the definition of**
5 **officer)**

6 After “employment” (wherever occurring), insert “or engagement”.

11 (c) any other person or body (including a foreign person or
12 body) prescribed by the regulations;

14 Omit all the words from and including “if the person” to and including
15 “its powers”, substitute “if the first person is satisfied that disclosure of
16 the information, or the production of the document, will assist that
17 agency or bank, or that other person or body, to perform its functions or
18 exercise its powers”.

21 (5) Subsection (2) does not prohibit a person from disclosing protected
22 information or producing a protected document to a person or body
23 (including a foreign person or body) if the disclosure or production
24 to that person or body is approved in writing by the Governor.

26 (5B) The Governor may, in writing, delegate to the Deputy Governor, or
27 an Assistant Governor of the Reserve Bank, the power to give
28 approvals under subsection (5).

4 this section to another person, the first person may, by notice in
5 writing given to the other person at the time of the disclosure or

9 (7C) A person commits an offence if the person fails to comply with a
10 condition imposed under subsection (7A).
