3     The Parliament of Australia enacts:

4     **1 Short title**

5                     This Act may be cited as the *Customs Amendment (Anti-Dumping*  
6                     *Commission Transfer) Act 2013*.

7     **2 Commencement**

8                     (1) Each provision of this Act specified in column 1 of the table  
9                     commences, or is taken to have commenced, in accordance with  
10                    column 2 of the table. Any other statement in column 2 has effect  
11                    according to its terms.

30 *Submissions*

- 31 (2) If:

- 1 (a) an investigation, review or inquiry under Part XVB of the  
2 *Customs Act 1901* is pending at the commencement of this  
3 item; and  
4 (b) before that commencement, submissions were received by  
5 Customs in relation to the investigation, review or inquiry;  
6 then, on and after that commencement, that Part has effect as if the  
7 submissions had been received by the Commissioner.

8 **105 Continuation of secrecy provision**

- 9 (1) A delegation in force under subsection 14(4A) of the *Customs*  
10 *Administration Act 1985* immediately before the commencement of this  
11 item continues to apply on and after that commencement.  
12 (2) Section 16 of the *Customs Administration Act 1985*, as in force  
13 immediately before the commencement of this item, continues to apply  
14 on and after that commencement in relation to the Commissioner and to  
15 information that came to the knowledge of, or into the possession of, the  
16 Commissioner before that commencement while he or she performed  
17 duties.

18 **106 Continuation of offences under the *Criminal Code***

19 Sections 146.1, 146.2, 147.1 and 147.2 of the *Criminal Code*, as in  
20 force immediately before the commencement of this item, continue to  
21 apply on and after that commencement in relation to conduct engaged in
