6 **1 Short title**

7 This Act may be cited as the *Farm Household Support*
8 *(Consequential and Transitional Provisions) Act 2014*.

2 Commencement

Schedule 3—Transitional provisions

1 Transitional application of section 40 of the *Farm Household Support Act 2014*

Section 40 of the *Farm Household Support Act 2014* applies, after the commencement of this item, as if the reference to an income support payment in paragraph 40(1)(a) of that Act included a reference to:

- (a) a transitional farm family payment made under the program known as the Transitional Farm Family Payment program; and
- (b) a payment of interim farm household allowance made under the program known as the Interim Farm Household Allowance program; and
- (c) a payment of interim income support made under the program known as the Interim Income Support program; and
- (d) an exceptional circumstances relief payment under the *Farm Household Support Act 1992*.
