About this list

Requirement to provide list for tabling

This list of legislative instruments has been prepared for laying before each House of Parliament in accordance with section 52 of the *Legislation Act 2003* (the LA).

This list sets out the legislative instruments that are due to sunset (that is, to be repealed by section 50, 51 or 51A of the LA) on 1 April 2023.

Under subsection 52(2) of the LA, the Attorney-General must arrange for this list to be laid before each House of the Parliament on the first sitting day of the House on or after 1 October 2021.

This list was up-to-date when prepared on 25 August 2021.

To assist the reader, the instruments are grouped by administering department, consistent with the Administrative Arrangements Order as amended on 2 July 2021.

If a department is not mentioned in the list, the department does not have any legislative instruments due to sunset on 1 April 2023.
