About this list

Requirement to provide list for tabling

This list sets out the legislative instruments that are due to sunset (that is, to be repealed by section 50, 51 or 51A of the LA) on 1 October 2025.

Under subsection 52(2) of the LA, the Attorney-General must arrange for this list to be laid before each House of the Parliament on the first sitting day of the House on or after 1 April 2024.

This list was up-to-date when prepared on 13 March 2024.
